**Assessments and Dam Repair**

Sherwood Lake Club may assess its members for expenses that cannot reasonably be paid from the normal operating funds of the Lake Club. The annual insurance assessment for 2023 was \$85 per member. There are currently known issues related to the dam which necessitate repair. The Lake Club has applied for a FEMA grant to pay for all or a portion of the repairs. We are hopeful the cost of repairs to be paid by the membership (assessment) for the dam will be greatly reduced after receiving the grant payment. Once known, the Lake Club board of directors will determine the appropriate allocation of costs (assessment), if any, between A and B members.
